HALF-DAY MEDIATION

\$200/hour/party for 2 parties

\$175/hour/party for 3 parties

\$150/hour/party for 4 or more parties

NOTE: A "party" is defined as all parties represented by the same counsel.

CANCELATION POLICY

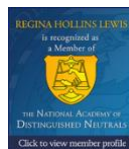
